A CO detector located above the generator room went off due to improper ventilation and the Fire Department evacuated the building. Mr. Mestres reported that the contractor had failed to comply with LHA and Township requirements. Mr. Weingarten asked who would be responsible for the cost of the incident. Ms. Grauso replied that the contractor bore responsibility and the LHA had no liability.

**Item 3.** Letter from Ms. Grauso to the Lakewood Board of Fire Commissioners regarding the future sale of the fire house located at the corner of South Clover Street and Sampson Avenue. Ms. Grauso informed the Board of LHA interest in the purchase of the building based on its location and the continued growth of the LHA, necessitating additional space.
