MEETING CALLED TO ORDER

Mr. Stafford Smith called the meeting to order at 6:12 pm. Ana María García announced that consistent with the Open Public Meetings Law: P.L.1975 c231, which requires that all meetings of public bodies shall be open to the public at all times, a notice of this meeting was provided to the clerk of the Township of Lakewood, the Ocean County Library, the Asbury Park Press, and the Star-Ledger on January 26, 2016, and was posted on the Authority's official designated public bulletin board at the LHA Administration Building, as well as the LHA website.

PRESENTATION BY THE OCEAN COUNTY HOMELESSNESS PREVENTION AND ASSISTANCE COALITION

Ms. Grauso introduced representatives from the Ocean County Homelessness Prevention and Assistance Coalition (HPAC) including, Taiisa Kelly from Monarch Housing Associates, Rose Bulbach from the Ocean County Department of Human Services, Meredith Sheehan from the Ocean County Board of Social Services, and Michael Blatt from the Ocean County Department of Human Services Office for Individuals with Disabilities.

In an effort to explore how HPAC and the LHA might partner in the effort to end homelessness in Ocean County, Ms. Kelly presented an overview of HPAC, some of the data regarding homelessness in Ocean County, as well as the direction HUD is moving in with regard to homelessness. She also shared several profiles of individuals and families in Ocean County who are homeless. Ms. Kelly then made the following recommendations to the Board:

- Establish a 10% homeless unit set aside of Housing Choice Vouchers (HCV) and Public Housing
- Create a separate homeless waiting list

Program (FUP) Demonstration and wished the LHA success in its implementation. The HUD Newark Field Office also sent its congratulations. Ms. Grauso commended the team from the New Jersey Department of Children and Families' Division of Child Protection and Permanency (CP&P) for its efforts with regard to the FUP Demonstration. The next step is for the LHA to submit its revised FSS Action Plan to HUD.

REPORT OF ATTORNEY

Mr. Corriston briefly reviewed Resolution No. 5177, explaining the need to pay off outstanding bonds prior to the Rental Assistance Demonstration (RAD) conversion. Failure to pay off the bonds will prevent the conversion.

On roll call approving, Mr. Stafford Smith, Ms. Heinemann, Ms. Caldwell, and Ms. Medina. Motion approved.
