EMPLOYEE HEALTH INSURANCE CONTRIBUTION RATES FOR 2023

WHEREAS, in 2011, the State enacted Chapter 78 which placed mandatory employee health insurance contribution rates into effect, which expired/sunset in 2015 other the requirement that employees must contribute a minimum of 1.5% of base salary towards their health benefit cost; and

WHEREAS, since 2015, each individual entity has the ability to negotiate/change their employee contribution requirements as long as the employees contribute a minimum of 1.5% of base salary; and

WHEREAS, due to the recent increase in health insurance costs, and the dramatic employee contribution percentage escalations at certain salary ranges within the State provided contribution chart, E.D. Parsons recommended a review of the health insurance contribution policy in order to mitigate the negative effect on the employees pay/raises and to improve the likelihood of employee retention; and

WHEREAS, E.D. Parsons met with the Personnel Committee on January 16th to discuss the existing contribution policy and its effect on employees, developing a new contribution policy moving forward, and the effects such changes will have on the operating budget; and

WHEREAS, after discussion, it was agreed to bring the recommendation to the board to freeze the employees' health insurance contributions for 2023 at the amounts they contributed in 2022 and to develop a revised contribution schedule, to be approved by the board, that will go into effect in 2024; and

WHEREAS, the operating budget can easily absorb the "freezing" as the HUD administrative fee proration increase from 89% to 91% will provide the LHA \$27,500 more revenue than budgeted while the "freezing" will result in the LHA absorbing approximately \$8,800 in additional cost over budgeted.

NOW THEREFORE BE IT RESOLVED by the Board that the employee health insurance contributions for 2023 will be frozen at their 2022 amounts and the E.D. will provide a revised contribution policy recommendation, before the end of 2023, for approval by the board to go into effect in 2024
