EXTENDING SHARED SERVICE AGREEMENT BETWEEN THE LAKEWOOD HOUSING AUTHORITY AND THE RAHWAY HOUSING AUTHORITY FOR BOOKKEEPING/TRAINING SERVICES

WHEREAS, N.J.S.A. 40A:12-17d provides that four members shall constitute a quorum of a Housing Authority for conducting business; and

WHEREAS, in light of the Department of Community Affairs' determination that the Commissioner was deemed resigned as of May 10, 2024, Authority Board of Commissioners' meeting held on July 11, September 5, September 25, October 10, and November 7 lacked a duly constituted quorum; and

WHEREAS, in order to rectify the situation, it is appropriate to readopt the following resolutions and actions approved during the meetings held between July 11 and November 7, 2024.
